3. **JOHN² DEVEREUX** (*John¹*) is mentioned as deceased in the will of his father, dated 4 Sept. 1693. He married **SUSANNAH HARTSHORN**, born at Reading 2 Mar. 1659/60, died at Watertown 5 May 1718, daughter of Thomas and Susannah of Reading. She married secondly, at Marblehead, 10 Jan. 1694/5, Stephen Parker of Andover. In the records of the First Church of Marblehead is the entry: "Susanna Devereux, a child of the Church of Reading, was admitted to full Communion in this Church, 2 Feb. 1689."

- iii. **ANN**, bapt. at Marblehead 24 Aug. 1690; m. at Marblehead, 31 Oct. 1706, her first cousin, **FAITHFUL BARTLETT** (1, vi, 2), b. about 1683, d. 10 Jan. 1748/9, in his 66th year, s. of John and Bethia (Devereux). Children: 1. *Bethia* (twin), b. at Marblehead 3 Sept. 170—; d. 21 June 1748 (*sic*, ? 1742), in her 35th year; m. at Marblehead. 4 Oct. 1726. Robert Hooper. 2. *Elizabeth* (twin).

3. **JONATHAN PHILLIPS**, of Marblehead, born in Watertown in 1697, died in Newport, R. I., in 1746. He married in Watertown, 27 Feb. 1716/17, **HEPZIBAH PARKER**, daughter of Stephen of Andover and Suzannah Devereaux (perhaps widow of John Devereaux and daughter of Thomas and Suzannah Hartshorne of Reading, who was married in Marblehead 10 Jan. 1694/5). He moved to Marblehead about 1719 and removed to Newport about 1744.

The PARKER FAMILY
OF ANDOVER

Joseph Parker, who, according to the terms of his will, had an estate in Ramsay, England was one of the first freeholders of Andover. He was in Newbury in 1642 and came to ANDOVER in October, 1645. His estate was on the site of the present Stevens' Mill in North Andover. John's wife was a Mary-- -, presumably Mary STEVENS. In his will, made 1678, John leaves the bulk of his property to Mary, with instruction for the care of two of their sons, who are non compos mentis, "by God's providence." Mary, also declared to be non compos mentis in wills, died in 1695.

At his death, Joseph appoints as overseers of his estate, his "loving brother, NATHAN PARKER, and loving friends, Lieut. John Osgood, Ensign Henry Ingalls, and Thomas Chandler."

NATHAN PARKER "the loving brother", died here in Andover, June 25, 1685. His first wife is said to have been Susan Short of Newbury, whom he married on Nov. 10, 1648; she died in Andover, Aug. 26, 1651; he took for a 2nd wife, Mary Ayer, daughter of John and Hannah of Newbury. Poor Mary was accused of witchcraft by Mercy Wardwell and William Barker,--confessed witches,-- who declared that she assisted them in tormenting Timothy Swan, who died that year. (1692). (His stone is in North Parish Yard.) Ten or more of the "witches" confessed to having their astral bodies appear at the bedside of sick Timothy, and torture him by punching him with iron spindles, pins and tobacco pipes. In consequence, Mary Parker was hanged at Salem in 1692.



Joseph(1) Parker and his wife, Mary, had:-
Joseph (2) b. m. Elizabeth Bridges in 1680; he d. 1684, leaving everything to Elizabeth, until his only son, Joseph(3) should be of age. His "dear and loving friends, Capt. Dudley Bradstreet and Capt. John Osgood" were to be overseers of the property. He died before he could sign the will, but Bradstreet and Osgood took oath that they drew up the paper three days before his death, and it held. The estate was valued at £ 402; included: Arms; Tools; Gristmill and water privileges: 60 acres over the Shawshin; 50 acres by Great Pond; 20 acres near the Shoe Meadow; 10 acres of upland by the Shawshin; an old house; barn; post-yard above the mill. Books at £ 1.
In 1686, widow Mary {Elizabeth} took for a 2nd husband, Samuel Hutchinson.

Stephen(2), b. 1651; m. 1st in 1680, Mary Marston, daughter of John Marston and w. Martha; she was b. 1655; d. 1693; he m. 2nd. Susanna Hartshorn who was previously married to John Devereaux of Marblehead; Stephen d. May 2, 1718.

Thomas(2), b . --- (really the 2nd son); d. 1708; non compos mentis; his land was sold for £ 143 to John Aslebe in 1704; with his brother Stephen, above.

Hester (2), b. 1654; not named in will of father.



John(2), b. 1656; killed in 1677 at Black Point, the sea end of Scarboro, Maine.



Samuel(2), b. 1659; m. March 19, 1689, Martha Gage; he bought a farm in Haverhill; was killed by Indians, Aug. 31, 1690. No ch. found

Ruth (2), b. 1660; m. a Gyle of Haverhill; had:

Joseph(3); Ebenezer(3); James (3);

Sarah (2) bapt. July 5, 1678; in will of father, called wife of Ben Sabin; was res. of New London, Conn. before 1710; she was m. in Medfield, July 15, 1678; (perhaps Mary Johnson, wife of Return Johnson of Medfield made the match, as she was here about that time.) Ben died in Pomfret, Conn.

Mary (2), b. ; m. Ben Frye of Andover, 1678, the year her father died; she was a widow in 1709 when quit-claims were signed on the estate of Sam(2).

Stephen Clarendon Phillips was descended from Rev. George Phillips, who was the son of Christopher Phillips, of Rainham, in the county of Norfolk, England. Rev. George Phillips was born in 1593, and was educated at Tittleshall. He entered Gouville & Cain's College, Cambridge, April 20, 1610, receiving the degree of A. B. 1613 and A. M. in 1617. He came to New England in the "Arbella" in 1630, and settled in Watertown, where he died. By a first wife, who was a Hayward, he had a son, Samuel, born in 1625, who graduated at Harvard in 1650, and succeeded Rev. Ezekiel Rogers as minister of Rowley. Samuel married, in 1651, Sarah, daughter of Samuel Appleton, a native of England, who was one of the first settlers of Ipswich. By a second wife (Elizabeth Welden) Rev. George Phillips had Zerobabel, February 5, 1632; Jonathan, October 19, 1633; Theophilus, April 28, 1636; Annible, October, 1637; Ephraim, 1640; Obadiah, 1641; and Abiel. Jonathan, one of these children, married, January 26, 1680, Sarah, daughter of Jeremiah Holland (Harvard College, 1645), was a schoolmaster and magistrate, and died at Watertown, his native place, in 1704. His children were Sarah, born September 14, 1682; Abigail, April 22, 1683; Jonathan, 1685; George, Nathaniel, Elizabeth, Ruth, Sarah and Hannah. Jonathan, one of these children, was born in Watertown, and married, February 27, 1717, Hepzibah, daughter of Stephen Parker, of that place. He removed, in 1719, to Marblehead, and, about 1740, to Newport, R. I., where he died. His children were Stephen, born July 18, 1718, Ruth and others. Stephen, one of these children, was born in Watertown, and married Elizabeth, daughter of Thomas Elkins, of Marblehead. He was a prominent man, deacon of the Congregational Church, and, in Revolutionary times, an ardent patriot and a member of the Committee of Safety and Correspondence. He died in Marblehead March 1, 1801.

Phillips Genealogies

(in.) Jonathan Phillips (son of Jonathan and Sarah: No. 15,) a carpenter; removed from Watertown to Marblehead about 1719, and about 1740 to Newport, R. I., where he died.
